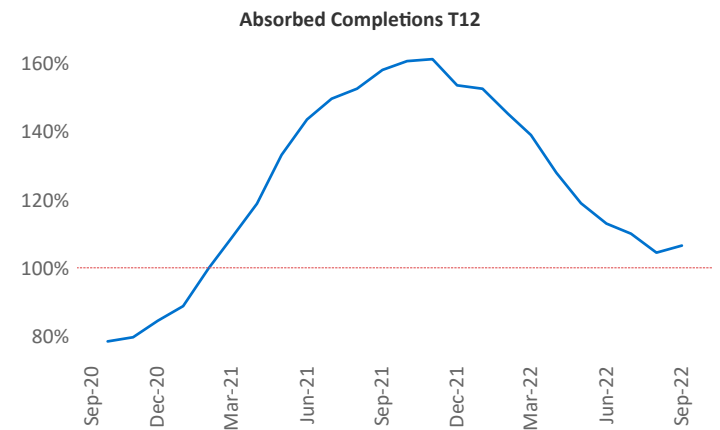
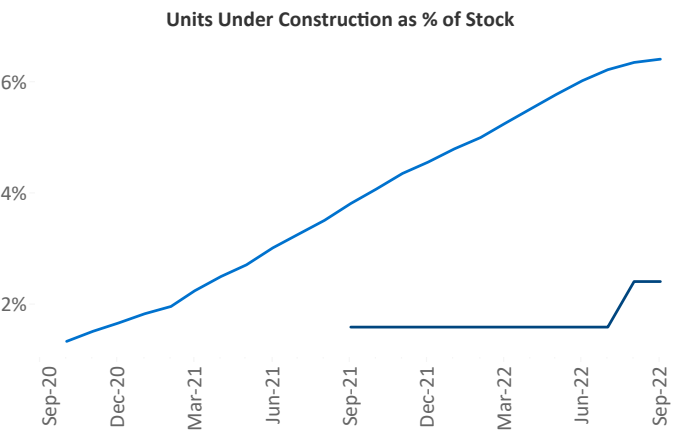
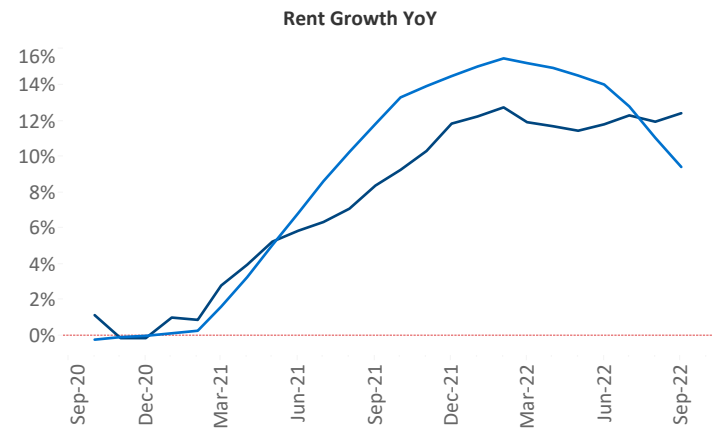
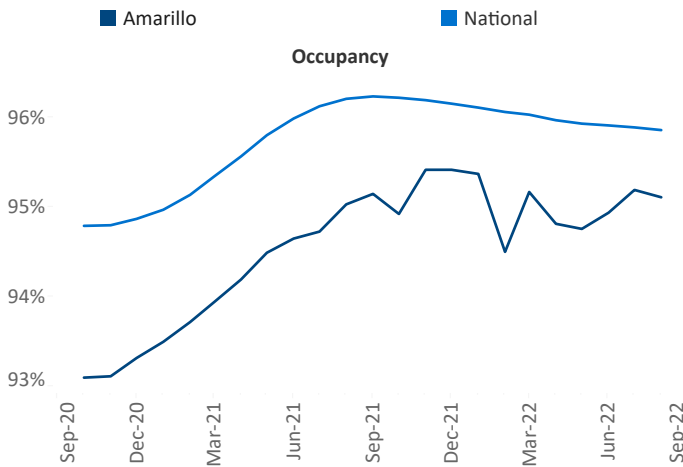


Amarillo is the **117th** largest multifamily market with **15,136** completed units and **775** units in development, **367** of which have already broken ground.

New lease asking **rents** are at **\$959**, up **12.4%** ▲ from the previous year placing Amarillo at **17th** overall in year-over-year rent growth.

Multifamily housing **demand** has been negative with **-168** ▼ net units absorbed over the past twelve months. This is down **-638** ▼ units from the previous year's gain of **470** ▲ absorbed units.

Employment in Amarillo has grown by **2.1%** ▲ over the past 12 months, while hourly wages have fallen by **-2.2%** ▼ YoY to **\$27.64** according to the *Bureau of Labor Statistics*.
