



Birmingham is the 56th largest multifamily market with76,034 completed units and 10,297 units in development,3,386 of which have already broken ground.


New lease asking **rents** are at **\$1,251**, up **7.9%** from the previous year placing Birmingham at **88th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **454** ▲ net units absorbed over the past twelve months. This is down **-1,058** ▼ units from the previous year's gain of **1,512** ▲ absorbed units.

Employment in Birmingham has grown by **4.0%** ▲ over the past 12 months, while hourly wages have risen by **3.6%** ▲ YoY to **\$26.96** according to the *Bureau of Labor Statistics*.
