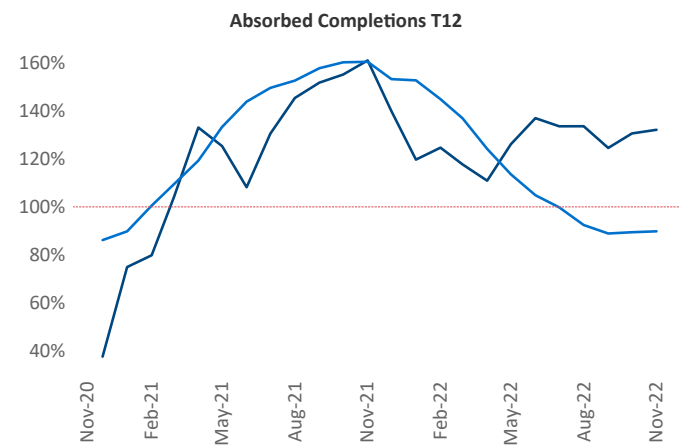
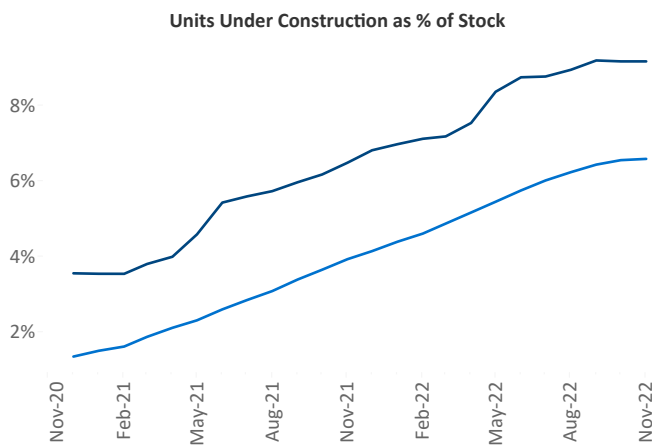
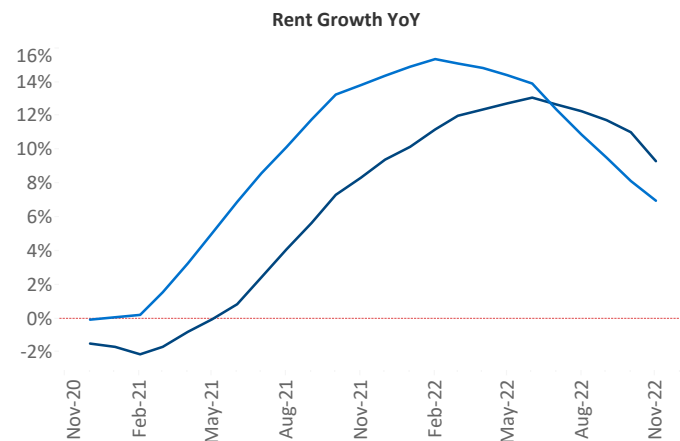
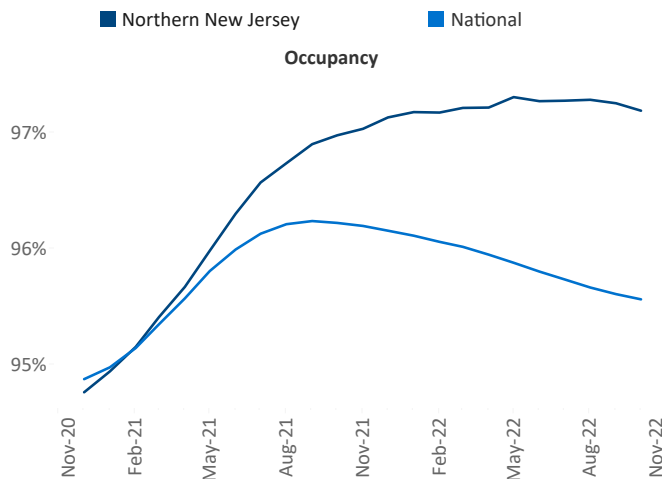
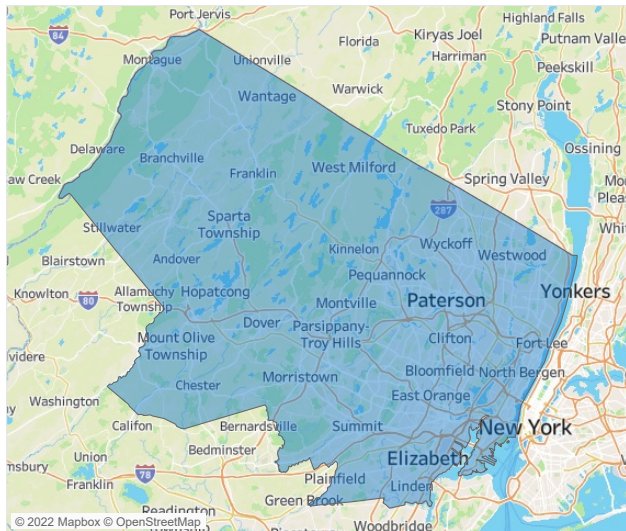
Northern New Jersey
November 2022

Northern New Jersey is the **16th** largest multifamily market with **251,790** completed units and **143,375** units in development, **23,059** of which have already broken ground.

New lease asking **rents** are at **\$2,360**, up **9.3%** ▲ from the previous year placing Northern New Jersey at **32nd** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **12,221▲** net units absorbed over the past twelve months. This is down **-1,516▼** units from the previous year's gain of **13,737▲** absorbed units.

Employment in Northern New Jersey has grown by **3.3%** ▲ over the past 12 months, while hourly wages have risen by **6.1%** ▲ YoY to **\$35.61** according to the *Bureau of Labor Statistics*.
