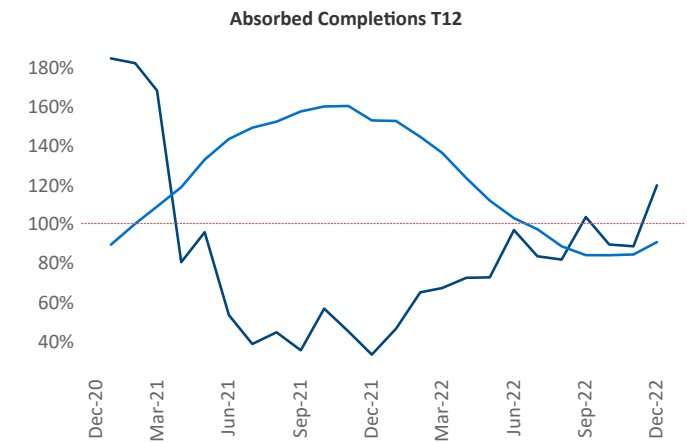
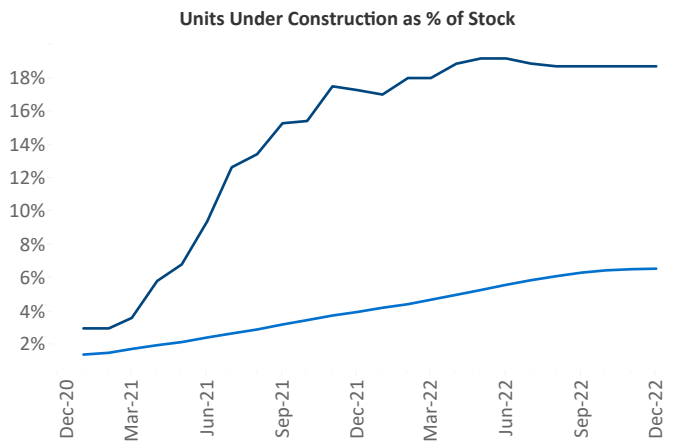
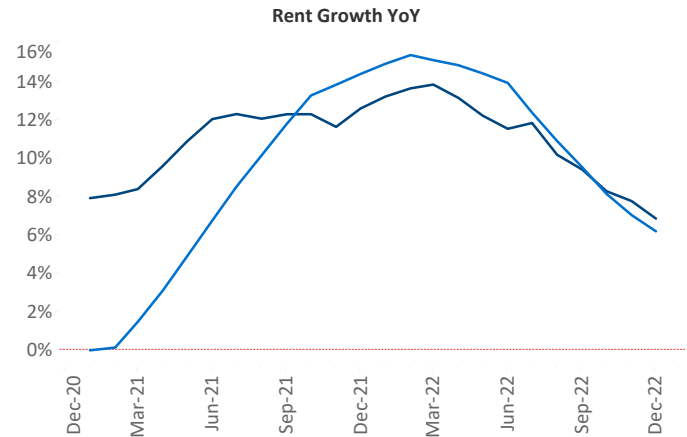
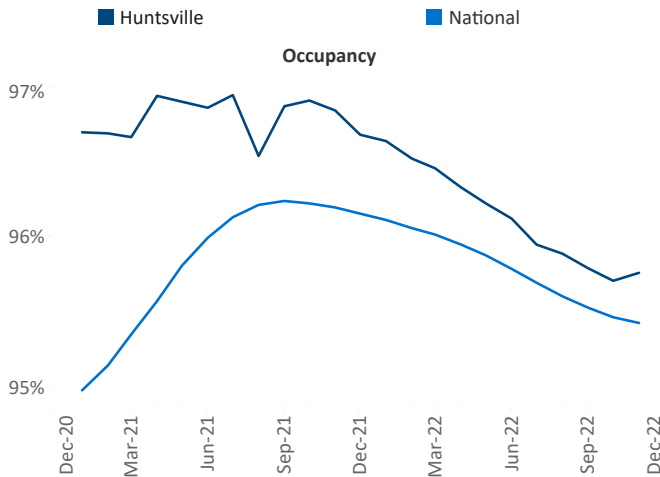


Huntsville is the **87th** largest multifamily market with **39,414** completed units and **15,312** units in development, **7,374** of which have already broken ground.

New lease asking **rents** are at **\$1,138**, up **6.9%** ▲ from the previous year placing Huntsville at **66th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **1,801** ▲ net units absorbed over the past twelve months. This is up **1,162** ▲ units from the previous year's gain of **639** ▲ absorbed units.

**Employment** in Huntsville has grown by **2.9%** ▲ over the past 12 months, while hourly wages have risen by **2.5%** ▲ YoY to **\$31.25** according to the *Bureau of Labor Statistics*.
