Athens is the 109th largest multifamily market with 22,160 completed units and 11,214 units in development, 2,261 of which have already broken ground.

New lease asking **rents** are at **\$1,387**, up **5.0%** from the previous year placing Athens at 64th overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with 611 A net units absorbed over the past twelve months. This is down -610 ▼ units from the previous year's gain of 1,221 ▲ absorbed units.

**Employment** in Athens has grown by **5.1%** over the past 12 months, while hourly wages have risen by 6.4% A YoY to \$26.98 according to the Bureau of Labor Statistics.




