

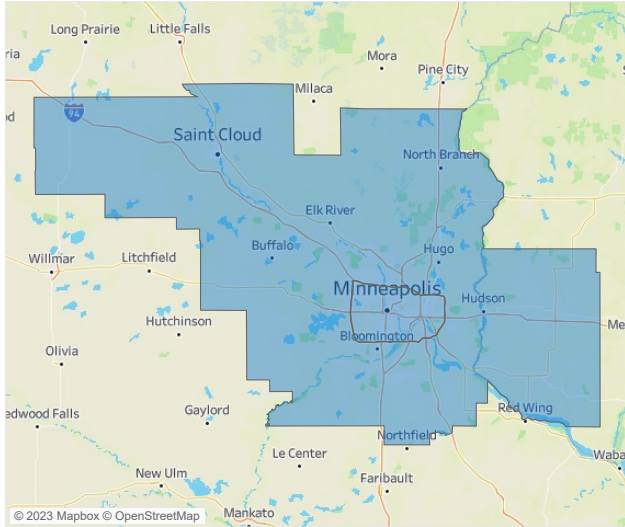

Twin Cities
May 2023



Twin Cities is the **18th** largest multifamily market with **240,565** completed units and **76,005** units in development, **10,922** of which have already broken ground.

New lease asking **rents** are at **\$1,477**, up **2.2%** ▲ from the previous year placing Twin Cities at **82nd** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **6,308** ▲ net units absorbed over the past twelve months. This is down **-3,532** ▼ units from the previous year's gain of **9,840** ▲ absorbed units.

Employment in Twin Cities has grown by **2.0%** ▲ over the past 12 months, while hourly wages have risen by **2.5%** ▲ YoY to **\$35.27** according to the *Bureau of Labor Statistics*.
