



Central Valley is the **41st** largest multifamily market with **123,165** completed units and **27,269** units in development, **3,450** of which have already broken ground.

New lease asking **rents** are at **\$1,543**, up **1.0%** ▲ from the previous year placing Central Valley at **74th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **1,298**▲ net units absorbed over the past twelve months. This is up **1,673**▲ units from the previous year's loss of -**375**▼ absorbed units.

Employment in Central Valley has grown by **1.5%** ▲ over the past 12 months, while hourly wages have risen by **4.8%** ▲ YoY to **\$29.67** according to the *Bureau of Labor Statistics*.
