

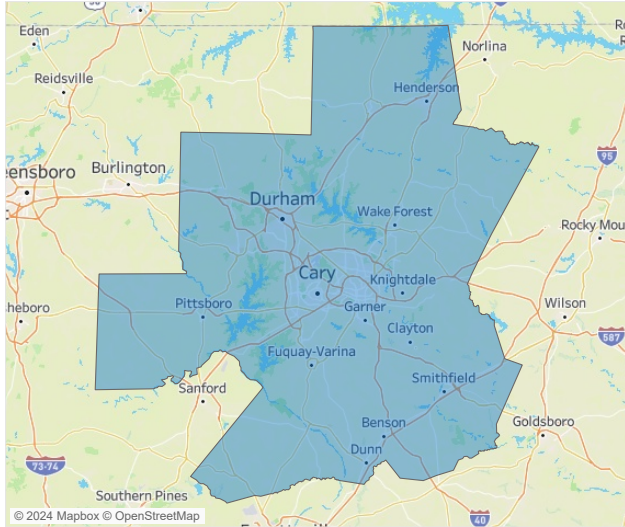

Raleigh - Durham

Raleigh - Durham is the **29th** largest multifamily market with **182,393** completed units and **132,851** units in development, **27,065** of which have already broken ground.

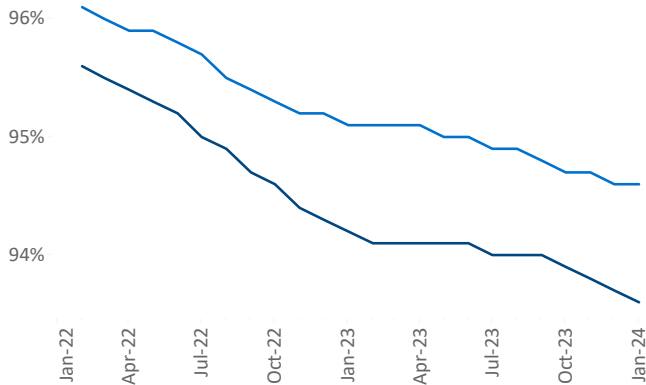
New lease asking **rents** are at **\$1,553**, down **-2.8%** ▼ from the previous year placing Raleigh - Durham at **111th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **6,449** ▲ net units absorbed over the past twelve months. This is up **5,032** ▲ units from the previous year's gain of **1,417** ▲ absorbed units.

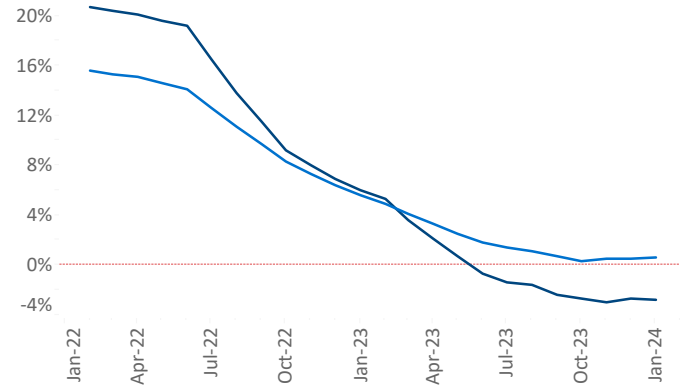
Employment in Raleigh - Durham has grown by **2.3%** ▲ over the past 12 months, while hourly wages have risen by **4.3%** ▲ YoY to **\$34.95** according to the *Bureau of Labor Statistics*.

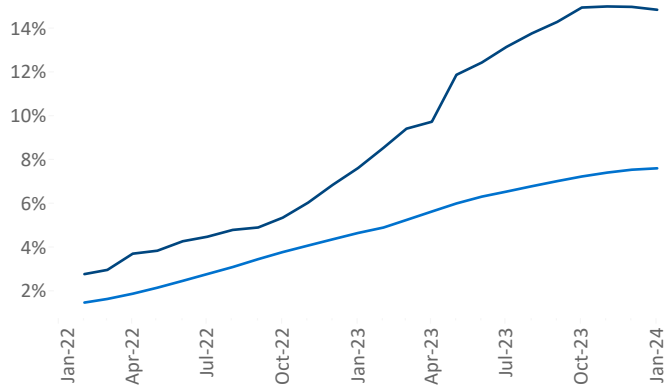
Occupancy
