


Boston is the 15th largest multifamily market with 266,473 completed units and 99,095 units in development, 19,817 of which have already broken ground.

New lease asking **rents** are at \$2,758, up 2.9% A from the previous year placing Boston at 41st overall in year-over-year rent growth.

Multifamily housing demand has been positive with **6,565** ▲ net units absorbed over the past twelve months. This is down -334 ▼ units from the previous year's gain of 6,899 ▲ absorbed units.

Employment in Boston has grown by **0.7%** A over the past 12 months, while hourly wages have fallen by **0.0% V** YoY to \$45.47 according to the Bureau of Labor Statistics.
