

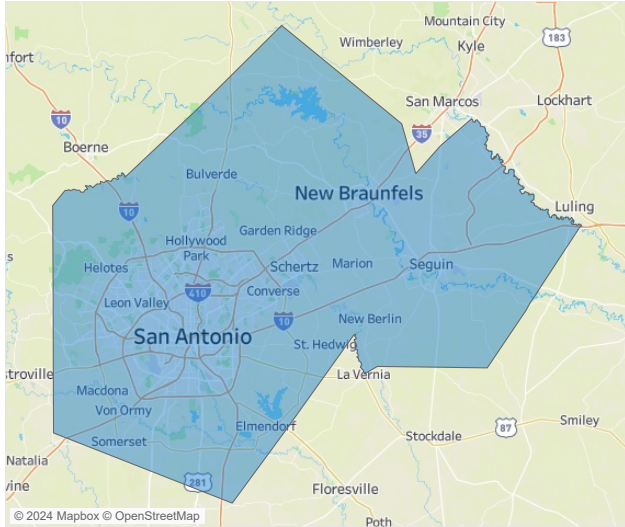

**San Antonio** is the **22nd** largest multifamily market with **223,773** completed units and **60,858** units in development, **21,453** of which have already broken ground.

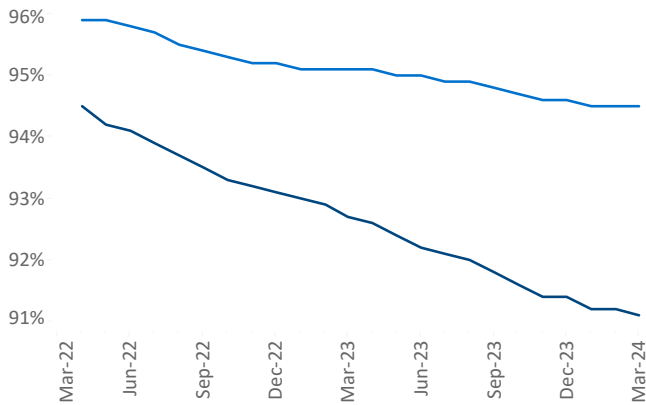
New lease asking **rents** are at **\$1,256**, down **-2.3%** ▼ from the previous year placing San Antonio at **110th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **2,553** ▲ net units absorbed over the past twelve months. This is up **5,462** ▲ units from the previous year's loss of **-2,909** ▼ absorbed units.

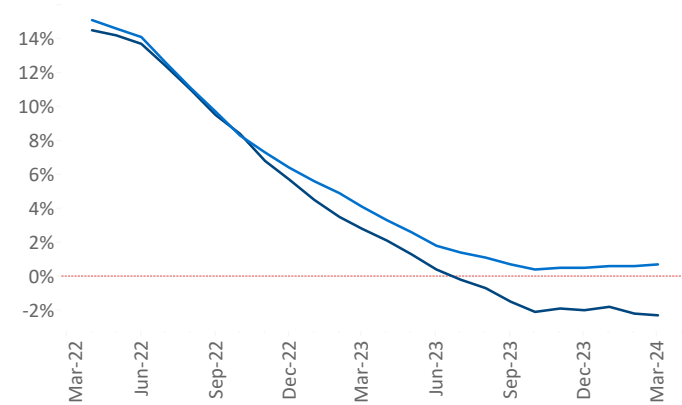
**Employment** in San Antonio has grown by **2.2%** ▲ over the past 12 months, while hourly wages have risen by **4.4%** ▲ YoY to **\$29.00** according to the *Bureau of Labor Statistics*.

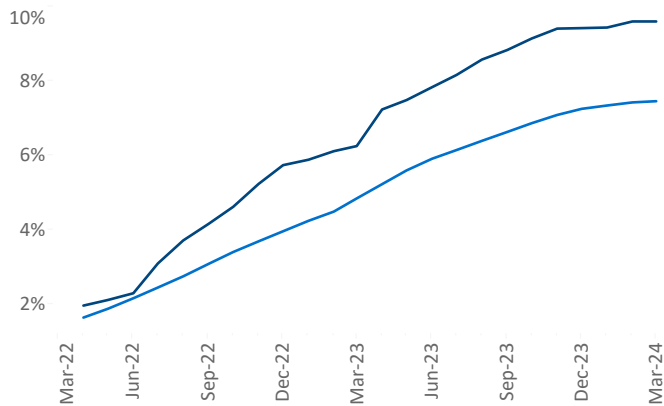
Occupancy
