

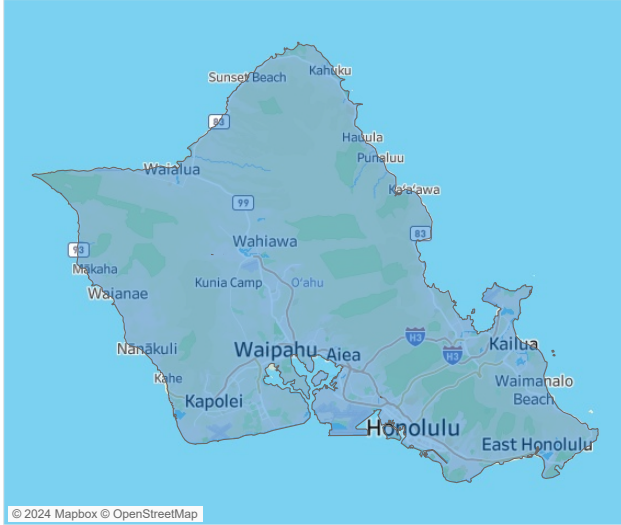

Honolulu
April 2024



Honolulu is the **109th** largest multifamily market with **23,292** completed units and **8,968** units in development, **1,443** of which have already broken ground.

New lease asking **rents** are at **\$2,649**, up **5.4%** ▲ from the previous year placing Honolulu at **7th** overall in year-over-year rent growth.

Multifamily housing **demand** has been positive with **994** ▲ net units absorbed over the past twelve months. This is up **347** ▲ units from the previous year's gain of **647** ▲ absorbed units.

Employment in Honolulu has grown by **1.4%** ▲ over the past 12 months, while hourly wages have risen by **1.2%** ▲ YoY to **\$37.91** according to the *Bureau of Labor Statistics*.
