



Scranton-Wilkes-Barre is the **119th** largest multifamily market with **12,557** completed units and **1,522** units in development, **187** of which have already broken ground.


Advertised **rents** are at **\$1,506**, up **3.2%** ▲ from the previous year placing Scranton-Wilkes-Barre at **33rd** overall in year-over-year rent growth.

Multifamily housing **demand** has been negative with **-231** ▼ net units absorbed over the past twelve months. This is down **-442** ▼ units from the previous year's gain of **211** ▲ absorbed units.


Employment in Scranton-Wilkes-Barre has grown by **2.5%** ▲ over the past 12 months, while hourly wages have risen by **4.6%** ▲ YoY to **\$25.89** according to the *Bureau of Labor Statistics*.


Occupancy
